1. Introduction & Overview

This document summarizes the Healthcare Coalition of Maine's (HCCME) Resource Assessment completed as a part of the 2022-2023 Work Plan. The Resource Assessment Report was developed for HCCME to better understand the resources available within the statewide coalition and outline the process (member organization to member organization) to request the identified resources. The assessment survey collected information on member owned resources and supplies necessary for planning and responding to an emergency.

This report is intended to provide a list of resources that could be made available to coalition members for planning, training, exercising, or responding to an emergency.

1.1 Methodology

To analyze coalition member organization's resources, the coalition created a survey, asking members to identify their organization's shareable resources. The coalition sent the survey out to membership on May 12th, 2023, asking them to list individual resources, the point of contact for the resource, steps to request the resource, and request link (if applicable). The survey closed on June 2nd, 2023. Twelve agencies responded to the survey.

- Acute care hospitals 5
- Skilled nursing, nursing, and long-term care facilities – 6
- Other healthcare type- 1

In addition to assessing physical resources across the coalition, HCCME collected information on available specialty services and used EMResource, a statewide web-based resource management platform, to collect hospital types and contact information. Limitations currently exist in EMResource, most notably that it has been used for the last several years for COVID resource reporting, for example the number of ventilators and ICU beds a facility has, rather than an overall bed count. The specialty services and data collected from EMResource that has been added to this report will be shared with all members to increase resource availability awareness.

2. HCCME Owned Resources

HCCME does not maintain a traditional cache of equipment or supplies. HCCME has developed an equipment property record to track equipment, medical materials, or supplies purchased with Hospital Preparedness Program (HPP) funds. The record specifically includes:

- Inventory list of materials purchased and location of materials
- Acquisition date, cost, invoices, calibration, and disposition information
- Policies regarding disposal

This equipment property record list is updated annually by the Coalition Coordinator in collaboration with the respective coalition member organizations. Should a coalition member organization receive HPP purchased equipment or supplies, they are responsible for maintaining, updating, and reporting the required inventory list on at least an annual basis. This information is to be submitted to the Coalition Coordinator upon request.

2.1 Policy for Requesting Coalition Resources

Coalition member organizations sign a membership agreement and are expected to “respond, as able, to local emergencies and disasters in collaboration with other coalition organizations” which would include sharing of resources.

Any resources identified in either the HCCME Resource Assessment or the equipment property record are maintained by the respective coalition member organization’s facility and will require agency-to-agency coordination to manage the resource request.

Individual coalition member organizations are responsible for identifying strategies for storage, rotation with day-to-day supply (as applicable) use, and disposal of the resource.

To request a resource, the requesting coalition member organization will contact the appropriate point of contact listed in the equipment property record that corresponds to the location of the resource. Coordination of transportation of those requested resources is the responsibility of the two coordinating parties.
